

## “\$5k Christmas Giveaway” Promotion

### Conditions of entry

<b>Promoter</b>	Australian Postal Corporation (ABN 28 864 970 579) trading as “Australia Post”, 111 Bourke Street, Melbourne, VIC 3000. Phone: 13 76 78.
<b>Entry Restrictions</b>	Open only to Australian residents who are aged 18 or over.  Directors, officers, management and employees (and the immediate families of directors, officers, management and employees) of the Promoter, or of the agencies or companies associated with this competition are ineligible to enter.
<b>Competition Period</b>	12.01am (AEDT) on 05/11/18 to 11.59pm (AEDT) on 25/11/18.
<b>Entry Method</b>	During the Competition Period, entrants must visit <a href="http://www.auspost.com.au/christmasgiveaway">www.auspost.com.au/christmasgiveaway</a> ( <b>Website</b> ) and fully complete and submit the online entry form, including by providing their full name, email address, mobile phone number and any additional information as required by the Promoter to receive an automatic entry into the draw ( <b>Entry</b> ).
