

Charity Mail service changes

Changes in the PreSort Letters and Charity Mail service guide effective 6 October 2014

This sheet summaries the changes made in the October 2014 edition of the PreSort Letters and Charity Mail service guide (8833700) – since the previous June 2014 edition.

For full details refer to the relevant sections of the service guide.

Charity Mail article sizes

Charity Mail is available for the *Small* and *Large* size categories. Previously, only Small articles were eligible.

Articles can weigh up to 125 grams.

All articles in a lodgement must be within the same size category.

- † Oblong: deviating from a square by being elongated in one direction. It is preferred that the length is at least 1.2 times the width. Articles with a length less than 1.2 times the width may be accepted subject to satisfactory test results.
- * A square is an equilateral rectangle.

Articles that fit within the dimensions of Small Plus and Medium for PreSort Letters are deemed to be Large articles for Charity Mail.

Plastic wrapping is acceptable for Small and Large articles (provided that Small articles are in Direct trays).

Delivery standards for Charity Mail

Large size category Charity Mail articles are only accepted for the Regular delivery standard.

Charity Mail articles for Priority delivery and for Regular delivery can be included on one lodgement document (provided that they are in separate trays). Previously, all Charity Mail articles in a lodgement needed to be for the same delivery standard.
