



Air Carriage within Australia fact sheet

Customers can choose to pay an Air Carriage premium and receive the same delivery standard as letters sent by Ordinary Post, based on a before 12 noon lodgement.

Air Carriage bag/tray labelling

For Air Carriage, articles are to be contained in Air Carriage bags /trays, with the relevant Print Post Air Carriage Label attached. Customers need to complete the Print Post bag /tray label in the same way as the surface carriage tray labels. It is important for air carriage that the correct destination label is used, as tabled below.

The following table designates:

- The Print Post Air Carriage Zones – defined by postcode ranges.
- The PreSort Indicator Numbers (PSI) used within these zones. (Refer to the Print Post sort plan for the complete Print Post Sort Plan.)
- The Destination city (and its abbreviation) for Air Carriage articles.
- The Print Post Air Carriage Label to be used for each destination. (Order or obtain these labels from your local lodgement facility. Order forms may also be printed or downloaded from the Australia Post website auspost.com.au/traylabels and provided to lodgement centres.)

Print Post Air Carriage within Australia is available only under special arrangements or agreements due to specialised labelling requirements.

Dangerous goods declaration

IMPORTANT: When articles exceed 500 grams and Air Carriage has been paid, the envelope or wrapper must carry the following endorsement – **“A No Dangerous Goods Declaration Has Been Completed”** – as required by Civil Aviation Legislation. The declaration itself is included in the *Print Post lodgement document*.

Example of a completed label

- 2 Postcode – if all for one postcode

Air Carriage surcharge

These charges, proposed effective from July 2025, are additional to the relevant Other State Print Post price.

2. The air carriage prices stated are an additional transport charge to the Print Post surface mail prices.
3. Minimum consignment per destination = 50kg.
4. Consignments below the minimum weight will be charged as if at the minimum weight.
5. Lodgements must be made by 12 noon at a designated mail centre.
6. Contract process stated, only provided air carriage to the major centre within each destination zone, from that point the articles will be transported by road to the final delivery point.
7. Prices stated are subject to change.
