

## Local Business Heroes 2023 Campaign (“Campaign”) Conditions of Entry

<b>Eligible Entrants</b>	<p>Open only to small businesses which meet the following criteria:</p> <ul style="list-style-type: none"> <li>• is a small business with less than 20 employees (as per ABS definition);</li> <li>• is an existing Australia Post business customer that sends through a MyPost business account, business credit account or Post Office;</li> <li>• sells products or services online;</li> <li>• is not a previous Local Business Hero winner; and</li> <li>• the business’ products/services align to Australia Post’s brand and values*.</li> </ul> <p>*For example, businesses that encourage, promote usage and/or is involved in/with the following will NOT be eligible: 1) drugs/alcohol, tobacco or vaping; 2) politics, war, terrorism, weaponry, death/violence; 3) encourage gambling; 4) infer sexual connotations/nudity; 5) make racial, ethical, religious, gender or cultural slurs; 6) make derogatory, libellous or defamatory comments; 7) make unfounded statements that have a conflict of interest (both personal and/or professional). <b>How to Enter</b>	<p>To enter, an authorised representative of the eligible business aged 18 years or over must, during the Application Period, visit <a href="https://cloud.email.auspost.com.au/lbhand">https://cloud.email.auspost.com.au/lbhand</a> and fully complete and submit the Local Business Heroes application form with all requested details and upload any files as required to support their application.</p> <p>The Promoter will not accept any applications submitted outside of the above online application form (e.g., mail/email entries) or outside of the Application Period.</p> <p>Applications and supporting documents submitted will sit in secured marketing cloud.</p> <p>Post Office team members and Australia Post Small Business Account Managers are eligible to complete a Local Business Heroes referral form for a small business which will trigger an email to the small business with a link to complete the application form. <b>Winner Determination</b>	<p>There will be a total of 100 winners determined for this Promotion who will each win the Customer Prize (details specified below). Applications will be assessed against other applications within their geographical Local Area Market (LAM) area and ranked against all applications received. Nothing in these conditions restricts, excludes or modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the Competition and Consumer Act 2010 (Cth).
  - 21 Without limiting the previous paragraph, the Promoter and its associated agencies and companies will not be liable for any damage, loss or delay in transit to prizes or be liable for any damage that occurs to prizes whilst displayed on premise at a Post Office.   - 22 The Promoter may communicate or advertise this competition using its social media accounts (e.g. Facebook etc.). However, the competition is in no way sponsored, endorsed or administered by, or associated with, its social media accounts.   - 23 If for any reason any aspect of this competition is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the competition, or invalidate any affected entries.
  - 24 The Promoter is not liable for any tax implications arising from prize winnings or acceptance and use of package elements. Independent financial advice should be sought.       - the non-compliance is unable to be remedied; or

    - the winner or any of the winner's personnel commit any act of fraud or dishonesty in relation to these Terms and Conditions;

- the winner engages in any conduct or activity that will harm, or is likely to harm, Australia Post's name, reputation, products or services, is offensive, corrupt or disreputable, or may bring Australia Post into disrepute, contempt, scandal or ridicule;
